ORDER

It has come to the notice of the Government that inundation of several colonies in twin cities and also in many other towns of the State and this kind of inundation of localities is happening due to large scale encroachments on low-lying areas on the dried up ponds / water bodies. Therefore, to take strict measures to evict the encroachers from the water body berms and low-lying areas and rehabilitate them in safer habitable zones a meeting was convened on the reclaiming of encroached lands in Nalas and Water Bodies in the said meeting among other things it has been decided to set up a task force with the officials of concerned departments for protecting and reclaiming such lands.

2. Accordingly, Government hereby constitute a committee with the following Members for taking steps required for protecting and reclaiming the encroached land.
