It would be indicative that the non-production of documents would cast in the minds of the Tribunal whether it has been purposely delayed. However, it is made clear that at-least before the next inspection of the Committee, which is scheduled to take place on 21<sup>st</sup> and 22<sup>nd</sup> August, 2015, the 1<sup>st</sup> respondent shall produce all the required documents which according to the Professor Dr. Mohan, were enlisted for production, thereby enabling the Committee to complete the work and file the report.

have not filed their reply despite the fact that they have got number of adjournments that too in the matter like this which has already been dealt by the Hon'ble High Court at Hyderabad and Hon'ble Apex Court.
